1. The Legal Defender, by and through undersigned counsel, has filed a Petition for Termination of Father's Parent-child Relationship pursuant to Title 8, of the Arizona Revised Statutes, Rules 4.1 and 4.2 of the Arizona Rules of Civil Procedure; and Rule 48(D) of the Arizona Rules of Procedure for the Juvenile Court.
2. The Court has set a Publication hearing on the 7<sup>th</sup> day of **March, 2022** at **2:30 p.m.** at the Cochise County Superior Court, Division II, 100 Colonia de Salud, Suite 200 Sierra Vista, Arizona 85635, before the

Honorable John F. Kelliher, Jr., for the purpose of determining whether any parent or guardian name herein is contesting the allegations in the Motion/Petition.

3. You and your child are entitled to have an attorney present at the hearing. You may hire your own attorney or if you cannot afford an attorney and want to be represented by an attorney, one may be appointed by the Court.

4. You have a right to appear as a Party in this proceeding. You are advised that your failure to appear in Court at the initial severance hearing, pretrial conference, status conference, or severance adjudication, without good cause shown, may result in a finding that you have waived your legal rights and have admitted the allegations in the Petition. In addition, if you fail to appear, without good cause, the hearing may go forward in your absence and may result in an adjudication of severance, termination of your parental rights or the establishment of a permanent guardianship based upon the record and the evidence presented to the Court, as well as an order of paternity, custody, or change of custody in a consolidated family law matter and an order for child support if paternity has been established.

5. If you are receiving this Notice by Publication; you may obtain the Motion/Petition for Father's Termination of Parent-Child Relationship, Notice of Hearing, and Temporary Orders by submitting a written request to: BRIAN MOLITOR, Office of the Legal Defender, PO Box 1858, Bisbee, AZ 85603. 6. Request for reasonable accommodations

7. You have the right to make a request or motion prior to any hearing that the hearing be closed to the public.
